KEEP ERIE SAFE

Citizen Support Committee
for the New Police Station
& Court Building



During the June 11, 2013 Board of Trustees meeting, the Board instructed Town staff to begin drafting a ballot measure for the April 1, 2014 election asking voters to approve construction of a new police station and municipal court building. In preparation for the April 1st election, the Keep Erie Safe citizen support committee has formed to promote the need for the new police station and court building.

Editor's Note: As of December 20, 2013, (print time for this issue of Erie Edition) the language for the ballot measure has not been approved. The Board is scheduled to consider both the ballot language and whether or not to move forward with placing it on the April 1st ballot during their January 28, 2014 meeting.

WE HAVE AN IMMEDIATE NEED.

The need for a new police building is real. The existing building poses many challenges for the 22 sworn officers and 3 civilian employees of the Erie Police Department. Erie's police department is approximately 2,400 square feet, dismal in size when compared to those of our neighbors. Our officers lack suitable space to conduct their business.

Since the police moved to their current location in 1999, Erie has more than tripled in population. Over time we will need to increase our staff, but as things stand right now there is simply no place to put them. The best officers want to work where they know they have the necessary support and resources available. Our current facility makes officer attraction and retention difficult.

As Erie continues to grow, the Erie Police Department will need to continually adapt in order to remain a professionally operated department that continues to be responsive to our citizens. The planned police and court building will serve the Erie Police Department and the Erie community for many years to come.

THIS BUILDING IS THE PRODUCT OF STUDY AND DESIGN.

This project has been in the planning stages for over four years. In 2010 the Town conducted a Space Needs Assessment which is, as the name implies, an analysis of current and future space needs of the Erie Police Department.

The assessment considered not only professional law enforcement standards and practices which influence space requirements, but also took into account the projected development and growth trends for the Town. If we were to build a smaller building, we not only fail to meet the needs of our community, we would end up paying more money in the long run through higher interest rates and increased construction costs. This is the building we need.

FINANCING ALLOWS FUTURE RESIDENTS TO PAY THEIR FAIR SHARE.

The building is for the Erie of today and tomorrow. Since the new building is designed to have a lifespan of at least 25 to 30 years, financing allows future Erie residents to pay their fair share. It just makes sense.



IT'S NOT GOING TO COST YOU A LOT, AND YOUR COST GOES DOWN OVER TIME.

Based on the current Assessed Valuation of the Town of Erie, the cost to the average homeowner would be approximately \$1 per \$100,000 in Assessed Valuation of your property, per month. So, if you own a \$300,000 home, your cost would be approximately \$3 per month or \$36 per year. However, as Erie continues to grow and more homes are built, your cost will decrease. Why? Because when there are more property owners to share the cost, the cost each property owner is responsible for decreases. Or put another way, as Assessed Valuation grows – each property owner's share shrinks.

APRIL 1, 2014: MUNICIPAL ELECTION

WHAT'S ON THE BALLOT

The Town of Erie will conduct its Regular Municipal Election on Tuesday, April 1, 2014. **During this election, registered voters in Erie will be electing a Mayor and five (5) Trustees.** The Mayor will be elected to serve a two-year term; three Trustees will be elected to serve four-year terms; and two Trustees will be elected to serve two-year terms. Voters will also have the opportunity to consider a ballot question seeking approval for the funding and construction of a new police and court building.

Background: The Town of Erie holds a Regular Municipal Election the first Tuesday of April in even-numbered years. Trustees serve four-year staggered terms; at every Regular Election there are three out of the six seats up for election. However, this year two Trustees elected in April of 2012 resigned from their positions creating two additional vacancies on the Board. The three (3) candidates for Trustee receiving the highest number of votes shall be elected for four (4) year terms, and the two (2) candidates for Trustee receiving the next highest numbers of votes shall be elected for two (2) year terms.

During the June 11, 2013 Board of Trustees meeting, the Board instructed Town staff to begin drafting a ballot measure for the April 1, 2014 election asking voters to approve construction of a new police station and municipal court building. Though the Ballot Measure has not been approved, it is anticipated the language on the ballot will be substantially similar to the one issued in 2012. The Board is scheduled to consider the ballot language during their January 28, 2014 meeting.



CANDIDATE INFORMATION & DEADLINES

- Erie residents interested in running for the Board of Trustees may pick up a Candidate's Packet from the Town Clerk's Office beginning on **Monday, February 10, 2014.**
- Each petition requires a minimum of ten signatures from registered electors within the boundaries of the Town of Erie. Registered electors may only sign one petition for the Mayoral candidacy and up to five petitions for the Board of Trustees candidates (only one signature per candidate). Completed petitions must be filed no later than **5:00 pm on Friday, February 28, 2014** with the Town Clerk's Office.
- The Town Clerk's Office has scheduled an informational meeting on **Monday, February 10, 2014 at 6:00 pm.** This meeting is not mandatory, however, information will be provided from the Secretary of State's Office regarding the Colorado Campaign and Financial Practices Act as well as other important candidate information.
- The last day for candidates to submit petitions to be included on the April 1st ballot is **5:00 pm on Friday, February 28, 2014.**

MAIL BALLOT INFORMATION

The Town Clerk's Office will mail the ballots by **March 10, 2014.** Erie voters may mail their ballot or drop off their ballot at Town Hall any time during normal business hours (8:00 am to 5:00 pm) and on Election Day from 7:00 am to 7:00 pm. Ballots must be received by 7:00 pm on Election Day. Registered voters who do not receive a ballot in the mail may request one from the Erie Town Clerk's Office.

VOTER REGISTRATION

HAVE YOU REGISTERED TO VOTE OR DO YOU NEED TO UPDATE YOUR REGISTRATION?

TO REGISTER TO VOTE YOU MUST BE:

- A United States Citizen
- Be 18 years old on or before the date of the election
- Reside in Colorado and in the municipal election precinct for at least 22 days before the election
- Registration is permitted on any day up to and including the day of the election

DEADLINE INFORMATION:

You may register either online, by mail or in person. Registration options are:

- Up to 8 days prior to the election voter registration is available via the Secretary of State's online voter registration system www.govotecolorado.com
- Prior to and including the day of the election voter registration can be conducted by your County Clerk and Recorder or Town Clerk

IN ADDITION TO REGISTERING TO VOTE YOU MAY:

- Change your address on your current voter registration record
- Change your party affiliation on your current voter registration record
